TERMS OF PAYMENT FOR BUS-BAR PROTECTION SCHEME ONLY (PACKAGE No. XVII AGAINST TENDER SPECIFICATION No. Sr. G.M -CPC-TENDER-SPARE NUM RELAY & C&R PANELS – 30/2010-11.

The payment to the Contractor under the Bus-Bar contract will be made by the Orissa Power Transmission Corporation Ltd as per the guidelines and conditions specified hereunder. All payments made during the contract will be on-account payment purpose only.

A) SUPPLY OF MATERIALS:

Ex-works price component of the equipment & materials shall be paid as below: (i) 1st **Instalment:** Fifty percent (50%) of the Exworks price component shall be paid on successful completion of inspection and testing and receipt of the materials/items at site and on submission of documents indicated herein under.

- (a) Evidence of dispatch & receipt (R/R of receipted L/R).
- (b) Contractor's detailed invoice & packing list identifying contents of each shipment.
- (c) Insurance Policy / Certificate.
- (d) Manufacturer's / Contractor's guarantee Certificate of Quality.
- (e) Material Dispatch Clearance Certificate (MDCC) for dispatch issued by Owner.
- (f) Test certificate.

(ii) 2nd Instalment Payment:

(a) Ten Percent (10%) payment after verification of material at site by the consignee.

(iii) 3rd Instalment Payment(Erection Payment):

Thirty Percent (30%) payment shall be made after erection of material at site and certification by engineer in-charge.

(iv) 4th & Final Payment:

The balance ten percent (10%) of the Ex-works price component shall be paid after successful commissioning of the complete Bus-Bar protection Scheme & handing over to Orissa Power Transmission Corporation Ltd.

Inland Transportation & Insurance Charges

Inland transportation and insurance charges shall be paid to the Contractor on pro-rata basis, as per the unit rates indicated in the Letter / Notification of Award, after receipt of materials/items at site and on presentation of the invoices along with supporting documents by the Contractor. However, these charges will be subject to a limitation that the aggregate of all invoices does not exceed the total amount indicated in the Letter of Award/ NOA.

B) ERECTION , TESTING & COMMISSIONING OF MATERIALS:

i) 90% (Ninety percent) of the erection price component will be paid on progressive basis depending on the actual work done i.e. on completion of erection, testing and commissioning of the respective items and on certification of the same by the owner.

ii) The balance 10% (ten percent) of the erection price component shall be paid within sixty (60) days after successful commissioning of the Bus-Bar Protection Scheme and issuance of Taking Over Certificate by the owner.
