GENERAL TERMS AND CONDITIONS

INSTRUCTION TO BIDDERS (CHECK LIST)

- 1. The bidders must read in detail the õinstruction to the bidderö and general terms and conditions before filling the tender documents.
- **2.** Experience: The bidders should be of registered order manufacturer. The bidder may submit the copy of past experience if any regarding supply of similar materials to GRIDCO/OPTCL.

3. TENDERS:

- a. Bidders must submit the tenders in duplicate in the specified specification only.
- b. Tender must be submitted in sealed envelopes superscribed as õQuotation for tender call notice no. 02/2013-14 (Lighting materials) and addressed to the General Manager, Electrical, EHT (O&M) Circle, Jeypore.
- c. Tender shall be submitted either in person or by registered post with A.D. Any other means of delivery shall not be accepted. Detailed postal address with Pin No, Telephone No, and FAX No. must be mentioned on the tender bid. Tender received after due date and time due to postal delay or any other reason will not be considered.
- d. Conditional offer will not be considered.

4. EARNEST MONEY DEPOSIT:

- i) The tenderers are required to deposit EMD (a) 1% of the estimated cost in shape of Bank Draft/ Pay Order only drawn in <u>favor of "EHT (O&M)</u> <u>Circle, OPTCL,Jevpore", payabale at Jevpore</u>. The EMD will be refunded to the unsuccessful bidders on written request after finalization of tender. No cheque shall be accepted. The tender without EMD will be liable for rejection.

SCOPE OF THE WORK & OTHER CONDITIONS OF CONTRACT

1. <u>SCOPE OF CONTRACT:</u>

The scope of contract shall be delivered free on road transport at destination or at our OPTCL site.

2. <u>PRICE/RATE:</u>

a. The price quoted should be firm, F.O.R. destination inclusive of freight, insurance, packing forwarding charges inclusive discounts if any.

b. Taxes if any shall be mentioned extra. The tenderer may quote rate in respect of different make materials as per schedule. Service tax if applicable shall be paid extra.

3. DESTINATION:

Different Grid sub-stations/Divisions under the Circle as mentioned below.

- i. 220 KV Grid Sub-Station, Jayanagar for materials of EHT (O&M) Division, Jayanagar.
- ii. 220 KV Grid Sub-Station, Therubali for materials of EHT (O&M) Division, Therubali.
- iii. 132 KV Grid Sub-Station, Kesinga for materials of EHT (O&M) Division, Kesinga.

4. <u>VALIDITY:</u>

The rate with terms and conditions of the offer shall be valid for a minimum period of 180 (one hundred eighty) days from the date of opening of tender.

5. TERMS OF PAYMENT:

100 % (Hundred Percent) payment with taxes etc. shall be made after receipt of materials in full land in good condition and verified thereof by the consignee subject to availability of funds from the Head quarters office.

6. <u>PENALTY:</u>

If the supply is not made within the stipulated delivery period the Penalty shall be imposed @ 0.5 % (Half Percent) per week subject to a maximum of 5% (five percent) of such portion of contract which remain undelivered within the stipulated period. The date of receipt shall be treated as the date of delivery. The imposition of penalty is however subject to force major condition

7. <u>DELIVERY:</u>

The materials in full quantity shall be delivered within 60 days of issue of purchase order failing which purchase order shall be liable for cancellation with forfeiture of EMD/Security Deposit. However early delivery shall be preferred.

8. <u>SECURITY DEPOSIT:</u>

The successful tenders will be required to deposit a sum amounting to 10 % (Ten percent) of the value of the contract in shape of BD/Pay order with the <u>General Manager</u>, <u>EHT (O&M) Circle, Jeypore</u>, within 2(two) weeks of receipt of work order & which will be released after Completion of the guarantee Period, on written request, duly verified by the Consignee. In the event of breach or default in all or any conditions of the work order, the General Manager (Elect.), EHT (O&M) Circle, Jeypore may forfeit the whole amount of Security Deposit. The security deposit shall not carry any interest.

9. <u>GUARANTEE:</u>

The materials covered under this contract should be guaranteed for trouble free and satisfactory performance against any defect in designing materials and workmanship for a period of at least 18 (eighteen) months from the date of delivery of 12 (twelve) months from the date in which the materials are put to service, which ever is earlier. Any defects noticed during this period should be rectified/replaced by the firm free of cost to OPTCL provided such defects are due to faulty design, bad workmanship or bad material used. The replaced materials also have similar guarantee.

10. <u>AUTHORITY:</u>

General Manager, Electrical, EHT (O&M) Circle, Jeypore.

11. <u>VAT & I.T. PAN :</u>

Clear xerox copies of valid VAT Registration Certificate, PAN & VAT Clearance Certificate, on the date of opening of tender should be submitted along with tenders without which tender will be rejected.

12. PAST EXPERIENCE:

The bidders are required to submit the list of their past experience if any in GRIDCO/OPTCL/Other Govt. Agency regarding similar supply along with supporting documents.

13. ADDITION & ALTERATIONS:

The authority reserves the right to alter in quantities of materials stipulated under the scope of works attached & also to accept/reject any or all the tender without assigning any reason thereof.
