#### **Instruction to Bidders**

1. Introduction- Odisha Power Transmission Corporation Limited (OPTCL), was incorporated in March 2004 under the Companies Act. 1956 as a company wholly owned by the Government of Odisha to undertake the business of Transmission and wheeling of electricity in the State. The Company owns Extra High Voltage Transmission System and operates about 11344 ckts of transmission lines at 400 KV, 220 KV & 132 KV levels and 100 nos. of Substations with Transformation Capacity of 10,642 MVA. The Management of OPTCL is interested to conduct a Comprehensive Safety Audit covering all the operational areas with special emphasis on Electrical Safety Audit / Fire Risk assessment and Disaster Management Planning for their 132 KV, 220 KV & 440 KV EHV Sub-Stations.

#### 2. Scope of Work-

- i. In order to conduct a realistic check, diagnostics survey and review all aspects of Safety Systems and Procedures both Management and Technical, the Safety Audit for EHT SubStations (400 KV, 220 KV and 132 KV) of OPTCL shall be carried out as per CEA Safety Regulations.
- **ii.** Audit shall be through physical inspection of all functional areas of the Substations with reference to all applicable Indian standards & statutory rules. The study will also identify the extent of compliance to Statutory Requirements, hazards (electrical shocks, fires etc) and other Unsafe Conditions, Unsafe Practices and Acts and suggest remedial measures.
- iii. Evaluation of Safety Manual, Safe Operating Procedures and Safe Maintenance Practices.
- iv. Review of Safety of Systems and Electrical Installation.
- **v.** Review of Safety in Material Handling
- vi. Suggest improvement over the existing Safety Systems & Procedures, if any.
- vii. Study of Disaster Management Plan and suggest for its improvement.
- viii. The following points shall be covered under the Safety Audit: Safety & Health Policy, Safety & Health of Organisation, Accident reporting, Investigation & analysis, Safety Inspections, Safety educations & training, First Aid, General working conditions, Hazard identification & control, Safe operating procedures, Work permit system, Waste Disposal, Personal protective equipments, Fire protection, Emergency Preparedness, Plant layout and area classification, Static electricity, New Equipment review, Lifting machines & Tackles, Access, Material Handling, Communication system adopted and Transportation.
- ix. Review of all aspects of Fire Safety.
- **x.** The methodology to be followed shall be specified with the time line.
- **xi.** The fast phage Safety Audit shall be carried out for the following Sub-Stations of OPTCL of different voltage levels:
  - a) 400/220 KV Sub-Stations -2 nos.
  - b) 220/132 KV Sub-Stations 6 nos.
  - c) 132/33 KV Sub-Stations 12 nos.
- **xii.** The Audit should be completed and final report shall be submitted within 120 days from the date of pressing of work order.

- **3.** Bidders are required to go through the details of Tender Specification and submit their bids in the following manner:
  - i) **Techno Commercial Bid** (Part-I Bid) in prescribed format (**Form-1 to 6**) in sealed cover super scribed as "**Techno Commercial Bid**" and containing the following:
    - Documents pertaining to Firm / Agency experience in this field & execution of similar orders.

- 5. The tender should reach the addressee on or before 3 PM of 02/01/2013. Bids received beyond the stipulated date and time will not be considered.
- **6.** The Techno Commercial bid shall be opened **on 02/01/2013 at 4.00 PM.** Those who qualify in the commercial bid shall be invited to give their presentations before a designated Committee on their creditability experience to prove their capability for completing the project, methodology to be followed and the time line. The date of presentation shall be intimated in due course.
- 7. The tender has to quote in the prescribed price bid format. Quoting in any other manner will not be entertained.
- **8.** Tender with over written or erased, not authenticated, illegible rate or rates not shown in figures and words will be liable for rejection.
- **9.** The rate quoted should be in Indian Rupees, FIRM and inclusive of all taxes & duties. The format for quoting of price is indicated in Part- II (Price Bid). If there is any discrepancy in quoted price in figures & in words the later shall be considered.
- **10.** The Date of opening of Price bid shall be intimated only to the bidder whose commercial bids are selected by the designated committee.

#### 11. TERMS & CONDITIONS:-
