- 2. EMD: EMD amounting to Rs.500/- (Rupees Five Hundred only) either in cash, to be deposited with D.D.O. Headqrs. office at OPTCL cash counter or in shape of D.D issued by any nationalized Bank in favour of the DDO, Headqrs. office, OPTCL, Bhubaneswar payable at Bhubaneswar is to be submitted with the tender. If the EMD is submitted by cash, the original Money Receipt is to be attached with the tender. Tenders without EMD shall not be accepted.

- 3. <u>Price</u>: Price should be FIRM on FOR destination i.e. OPTCL, Bhubaneswar basis. **Taxes and duties if** any, should be mentioned in clear terms separately.
- 4. **Validity**: The offer should remain valid for a period of 90 days from the date of opening.
- 05. **Delivery**: The user licenses are to be delivered, installed, commissioned and demonstrated successfully at the GRIDCO Hqrs, office premises within 30(thirty) days from the date of issue of the purchase order.
- 6. Warranty: Each user license should be valid for one(1) year from the date of commissioning of that user license. Accordingly installation certificate should be furnished mentioning the date of installation for each user license.

- (c) The Bank Guarantee shall be valid for a period of 15 (fifteen) months from the date of delivery of all user licenses. The original Bank Guarantee accompanied with a confirmation letter from the concerned bank shall be submitted in this office.
- 09 **VAT & PAN**: Clear xerox copies of VAT & PAN registration should be submitted along with Tender papers.
