## SECTION-I

#### **INSTRUCTIONS TO BIDDERS:**

- Sealed Tenders in triplicate on two part basis (each complete with all details in the manner specified together with drawings, test reports, descriptive literature if any, and declaration form duly signed by tenderer are to be submitted in the office of the Sr. G.M. [CPC], ORISSA POWER TRANSMISSION CORPORATION LTD, Bhubaneswar in double sealed cover and superscribed the relevant tender specification number and due date of opening as indicated in the 'Notice Inviting Tenders'.
- 2. The specification is divided into two parts viz.**Part-I & Part-II.** Part I consists of four sections
  - (i) Section I Instruction to Bidders.
  - (ii) Section II General Conditions of Contract.
  - (iii) Section III Schedules & Annexures.
  - (iv) Section IV Technical Specification

#### Tenders shall be in Two parts

- 3. The purchaser reserves the right to alter the quantities with respect to materials/equipments/volume at the time of placing orders. Orders may also be split up among more than one bidder for any particular item/work.
- 4. Part I of the tender will be opened in the office of Sr. G.M. [CPC], OPTCL in presence of such of the Tenderer or their authorized representative (limited to one person only with a valid authorization from his employer). At the time of opening, the tech no-commercial bids and other relevant details will be read out. Price bid of successful Tech no-commercial bidders would be opened at a latter date with due information to the successful bidders.

- 5. The tenderer may deviate from the specification while quoting if in his opinion such deviation is in line with the erectors standard practice and conducive to a better and more economical offer. All such deviations should however be clearly indicated giving full justifications for such deviation separate sheet(s) under 'Deviations' title.

- 7. The purchaser reserves the right to reject the lowest or any other tenders or all tenders without assigning any reason what so-ever if it is considered expedient in the overall interest of OPTCL.
- 8. The tender should be in one part consisting of for Tech no commercial details and prices. The tender shall be submitted in triplicate and should be enclosed in double sealed cover both addressed to the Sr. G.M.[CPC], ORISSA POWER TRANSMISSION CORPORATION Ltd., Finance Wing, Janpath, Bhubaneswar 751 022. Both inner and outer cover should be sealed and superscribed with Tender Specification number and date of opening, (No.1 envelope should contain the original copies of technical parts of the specification with schedules and form including receipt of Earnest Money deposit and the No. 2 Envelope should contain original and copies of price bid as per the enclosed schedule). - 9. Tenders received after due date and time shall be returned without being opened.

  Telegraphic or Fax Tenders shall not be accepted under any circumstance.
- 10. EARNEST MONEY DEPOSIT:

The tender shall be accompanied by Earnest Money Deposit of Rs 25,000/-

The Earnest Money Deposit shall be offered in one of the following forms subject to the conditions mentioned below —

- (a) Bank Guarantee from any Nationalized Bank as per enclosed proforma.

  The validity of the above EMD BG shall be 180 days from the date of opening of tenders failing which the tenders will be liable for rejection.
- (i) No interest shall be paid on Earnest Money Deposit. No adjustment towards Earnest Money Deposit shall be permitted against any outstanding amount with OPTCL.
- (ii) In the case of unsuccessful tenderer, the Earnest Money will be refunded after finalization of tender. In case of successful bidder Earnest Money will be refunded only after furnishing performance security.
- (iii) Earnest Money/Performance Security will be forfeited if the tenderer fails to accept the letter of intent and/or purchase orders issued in his favour.

Tenders not accompanied by Earnest Money shall be disqualified.

- 11. Validity The tenders should be kept valid for a period of 120 days from the date of opening of the tenders as notified in the tender notice failing which the tenders will be rejected.
- 12. Tenderer are expected to be fully conversant with the meaning of all the clauses of the specifications before submitting their tenders. In case doubt regarding the meaning of any clause, the tenderer may ask for clarification in writing from the Sr. General Manager (CPC), OPTCL, Bhubaneswar which must reach at least 15 days before the scheduled date of opening of tender. This however, does not entitle the tenderer to ask for time beyond due date fixed for receipt of tender.

- 13. The tenderer should comply the following requirements along with the offer.
  - (i) Adequate similar type Experience in Supply, Dismantling, Erection / Stringing, Testing and commissioning of OPGW on EHT transmission lines (132KV or above) and restoration of communication signal in the same.
  - (ii) The bidder should have Valid HT/EHT Electrical contractor license from the competent authority on the date of submission and opening of the tender.
  - (iii) The bidder should be financially stable and their status should meet the financial obligation pursuant to the scope of the works. Their P/L and balance sheet for the last two years may be submitted.
  - 14. The successful bidder is required to furnish all designs, Drawings, Literatures in respect of the said work at his own cost within 15 days of placement of LOI/PO; otherwise the same is liable for rejection without notice.
  - 15. Bidders are required to submit tenders in the following manner. All documents/information enclosed in schedule –IV and as described below shall be placed in a double sealed cover .
  - 16. Other important terms and conditions.
    - **16.1** The firm should include the work contract tax if any in the quoted price.
    - **16.2** The firm shall not include entry tax and service tax in the quoted price which shall be reimbursed to them as per prevailing rate subject to production of documentary evidence.

# SECTION – II GENERAL CONDITIONS OF CONTRACT

#### 1. **DEFINITION OF TERMS:**

In writing these General Conditions of Contract, the specification and bill of quantity, the following words shall have the meanings hereby indicated, unless there is something in the subject matter or content inconsistent with such construction.

"OPTCL" shall mean the ORISSA POWER TRANSMISSION CORPORATION Limited represented through the Sr. General Manager (CPC).

"The Engineer in charge" shall mean the Engineer or Engineers authorized by the Chief Engineer(TP) for the purpose of this contract.

"OPTCL Engineer" shall mean any Engineering person or personnel authorized by the OPTCL to supervise and inspect the dismantling, stringing testing and commissioning of OPGW on 132KV Chandaka-Mancheswar Line.

The Contractor" shall mean the successful bidder awarded with the contract or their successors and permitted assigns.

"Contract Price" shall mean the sum named in or calculated in accordance with the provisions of the contract as the contract price.

"General Conditions" shall mean these General Conditions of Contract.

"Specification" shall mean the specification annexed to these General Conditions of contract and shall include the schedules and drawings attached thereto or issued to the contract as well as all samples and patterns, if any.

"Month" shall mean calendar month.

"Writing" shall include any manuscript, typewritten, printed or other statement reproduced in any visible form whether under seal or under hand.

#### 2. **CONTRACT DOCUMENT:**

The term "Contract" shall mean and include the General Conditions, specifications, schedules, drawings, work orders issued against the contract, schedule of price or the

final general conditions, any special conditions applying to the particular contract specification and drawings and agreement to be entered into. Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act falling that in the Orissa General Clauses Act.

#### 3. MANNER OF EXECUTION:

- (i) Dismantling of OPGW from existing line on Chandaka-Mancheswar Ckt I for a line length of 1.25Km (approx) as per the direction of Engineer in charge.
- (ii) Supply of OPGW with necessary hard wares & fittings for a line length of 1.8Km, Erection / stringing, testing and commissioning of the same on diverted route of Chandaka- Mancheswar 132KV line at Bhubaneswar.
- (iii) Restoration of speech and data communication in the above link between Chandaka to Mancheswar which is to be certified by Engineer in charge.
- 3.1 shall be carried out in an approved manner as described in the technical specification and, in accordance with relevant Indian / International Standard Specification, to the reasonable satisfaction of the Engineer.
- 3.2 The contractor shall within 10 days after the date of acceptance of letter submit to the engineer, a detail program for the execution of work for his consent. The contractors shall whenever required by the engineer also provide in writing for his information in general description of the

arrangements and methods which the contractor proposes to adopt for the execution of the work.

3.3 If at any time it should appear to the engineer that the actual progress of works does not conform to the program to which consent has been given under sub-clause-3.1, the contractor shall produce at the request of the engineer a revised program showing the modification to such program necessary to ensure completion of the works within the time of completion.

#### 4. Taxes and duties:

4.1 All duties, taxes and other levies payable by the bidder in respect of the transaction between the bidders and their vendors while preparing any components sub assembly ,raw materials ,erection cost shall be included in the bid price and no claim on this behalf shall be entertained by the owner.

However, any entry tax as applicable for destination site on all items of supply shall not be included in the bid price. The applicable entry tax in respect of the said items of supply would be reimbursed to the contractor separately subject to furnishing of documentary evidence.

VAT, Sale tax, Entry tax, any other levies should be clearly mentioned on the price schedule.

#### 5. VARIATION, ADDITIONS & OMISSIONS:

The OPTCL shall have the right to alter, amend, omit or otherwise vary the quantum of Supply and erection work by notice in writing to the contractor/Firm. The contractor/Firm shall carry out such variation in accordance with the rates specified in the contract so far as they may apply and where such rates are not available, those will be mutually agreed between the OPTCL and the Contractor.

#### 6. INSPECTION & TESTING:

The Engineer in charge or his authorized representative (s) shall be entitled at all reasonable times to inspect all materials including hardwares covered under this contract at site upon receipt of call from the contractor. The contractor is to provide technical datas and measuring instrument for physical verification and testing of the materials. Dismantling and stringing of OPGW on the transmission line shall also be supervised by OPTCL engineer. However Such inspection will not release the contractor from their obligations under this

contract, to perform as per specification and standard. Advance intimation must be given to Engineer –in-charge whenever it is needed prior to execution of work.

After completion of the work in every respect the new OPGW link in the diverted route shall be tested for restoration of the speech and data which shall be witnessed by Engineer-in-charge. On successful completion and operation of the system he shall issue one performance certificate on the quality of the work completed by the contractor, this certificate shall be issued within three days from commissioning and restoration of the new OPGW link.

#### **7.COMPLETION OF WORK:**

Time being the essence of contract, all supplies, stringing and commissioning and verification of the works by OPTCL Engineer shall be completed within the period specified i.e **within Three months** from the date of placement of the LOI/ work order which ever is earlier.

#### **8.CONTRACTORS DEFAULT LIABILITY:**

OPTCL may upon written notice of default to the Contractor/Firm terminate the contract in circumstances detailed hereunder.

- 8.1(i) (a) if, in the judgment of the OPTCL, the contractor/Firms fails the complete the scope of work within the time specified in the contract agreement or within the period for which the OPTCL has granted extension to the contractor.
  - (b) If, in the judgment of the OPTCL, the contractor fails to comply with any of the provisions of this contract.
- 8.1(ii) In the event OPTCL terminates the contract in whole or in part as provided in paragraph
  (i) above, OPTCL reserves the right to engage another contractor or agency upon such terms and in such a manner as it deem appropriate and the contractor will be liable to OPTCL for any additional costs as may be required for the completion of the line and/or

for penalty for delay as defined under this contract until such reasonable time as may be required for the final completion of the line.7.1(iii) In the event OPTCL does not terminate the contract as provided in paragraph (i) the contractor/Firm shall continue the performance of the contract in which case he shall be liable to the OPTCL for penalty for delay as set out in this contract until the lines are completed.

#### **9.FORCE MAJEURE:**

The contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of FORCE MAJEURE such as acts of God, acts of public enemy, acts of Government, cyclone, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes provided that the contractor shall within 10(ten) days from the beginning of such delay notify the OPTCL in writing of the cause of delay. The OPTCL shall verify the facts and grant such extension as facts justify.

#### **10.REJECTION OF WORKS:**

In the event of any of the material supplied/work done by the contractor is found defective in material or workmanship or otherwise not in conformity with the requirement of this contract specification, OPTCL shall either reject the material and/or work and request the contractor to rectify the same. The contractor on receipt of such notices rectify or replace the defective material and rectifies the work, free of cost. If the contractor fails to do so the OPTCL may,

- (a) at its option replace or rectify such defective materials and/or work and recover the extra cost so involved from the contractor plus fifteen per cent of the extra cost from the contractor and/or
- (b) Terminate the contract for balance work/supplies with enforcement of penalty as per contract.

(c) Defective materials/workmanship will not be accepted under any condition and shall be rejected outright without compensation. The contractor shall be liable for any loss/damage sustained by OPTCL.

#### 11. EXTENSION OF TIME:

If the completion of work is delayed due to reason beyond the control of the contractor, the contractor shall without delay give notice to the OPTCL in writing of his claim for an extension of time. The OPTCL on receipt of such notice may agree to extend the contract completion date of the line as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 12. GUARANTEE PERIOD:

The work done/material supplied by the contractor as per the contract specification should be guaranteed for satisfactory operation and against any defect in material and workmanship for a period of 18 (eighteen) months from the date of taking over of the system by OPTCL or 12(twelve) months from the date on which the system have been put to service whichever is earlier. The above guarantee certificate shall be furnished in triplicate to the purchaser for his approval. Any defect noticed during this period should be rectified by the supplier free of cost to OPTCL upon written notice provided such defects are due to bad workmanship or bad materials used. The date of delivery of system as read in this clause shall mean the date taking over the system by OPTCL

The contractor shall furnish contract performance guarantee for the proper fulfillment of the contract within 30 days of Award of contract.

#### 13. PERFORMANCE GUARANTEE:

Before issue of final taking over certificate (TOC) by the Engineer in charge the contractor shall provide OPTCL a Performance Bank Guarantee from a Nationalized/Scheduled Bank for an amount of 10% of the contract price in the approved

proforma of the OPTCL. This Bank guarantee shall be executed in a stamp paper worth Rs.50/- or any other amount as per the Odisha Stamp Duty Act and shall be kept valid till completion of the guarantee period mentioned in the foregoing clause.

OPTCL shall pay no interest for the aforesaid bank guarantee. In case of nonperformance of the line work as per the contract specification, the performance bank guarantee shall be en cashed by OPTCL..

#### 14. TERMS OF PAYMENT:

1. The contractor shall present a bill for the works completed, inspected, duly checked and measured & certified by OPTCL Engineer-in-charge, as per OPTCL norm at the charges/rates accepted along with materials utilization certificate of OPTCL's supply materials issued. 100% value of the consignment with 100% Excise duty, Entry tax if any and Sales tax in full as applicable along with freight & Insurance charges will be paid subject to furnishing and approval of performance Bank Guarantee @ 10% (Ten percent of the cost of the project along with guarantee Certificate and Test Certificate by the Purchaser.

#### 15. PENALTY

If the contractor fails to complete the erection, testing and commissioning etc. within the phased delivery schedule specified in the work order or any extension granted thereto, the OPTCL shall recover from the contractor as penalty a sum of half of one per cent (0.5%) of the contract price of the uncompleted portion of the system for each calendar week of delay. For this purpose, the date of taking over shall be reckoned as the date of completion. The total penalty shall not exceed 5% (five per cent) of the contract price of the uncompleted portion of work.

**16.1 INSURANCE:** The contractor shall arrange insurance coverage for the OPTCL materials at his custody and system works under execution by him as per the condition laid down in the relevant clause of the technical specification.

**16.2** The contractor shall take up Group Insurance or such other measures for his work force as well as OPTCL supervising staff and officials covering the claim for damage to personnel during supervision of work and other applicable State/Central laws. OPTCL shall not bear any responsibility on this account.

#### 17. PAYMENT DUE FROM THE CONTRACTOR:

All costs of damages for which the contractor is liable to the purchaser will be deducted by the purchaser from any money due to the contractor under the contract.

#### 18. JURISDICTION OF THE HIGH COURT OF ODISHA:

Suits, if any, arising out of this contract shall be filed by either party in a Court of Law to which the jurisdiction of the High Court of Orissa extends.

#### 19. CONTRACTORS/Firms RESPONSIBILITY:

19.1 Not withstanding anything mentioned in the specification or subsequent approval or acceptance of the line by OPTCL, the ultimate responsibility for satisfactory performance of the line shall rest with the contractor.

#### 19.2 RESPONSIBILITY TO RECTIFY THE LOSS AND DAMAGE:

If any loss or damage happens to the work or any part thereof or materials/plant/equipments for installation therein during the period of execution and till final handing over; the contractor is responsible for the same and shall at his own cost rectify/replace such loss or damage, so that the permanent work confirms in every respect with the provision of the contract to the satisfaction of the engineer. The contractor shall also be liable for any loss or damage to the work/equipment caused by him in course of any operation carried out by him during performing the contract.

#### 20. **NON-ASSIGNMENTS:**

The contractor shall not assign or transfer the work orders issued as per this contract or any part thereof to anyone else without the prior approval of OPTCL.

#### 21. CERTIFICATES NOT TO AFFECT RIGHTS OF OPTCL:

The issuance of any certificate by OPTCL or any extension of time granted by OPTCL shall not prejudice the rights of OPTCL in terms of the contract nor shall this relieve the contractor of his obligations for due performance of the contract.

#### 22. SETTLEMENT OF DISPUTES:

- 22.1 Except as otherwise specifically provided in the contract, all disputes concerning question of fact arising under the contract shall be decided by OPTCL provided a written appeal by the contractor is made to OPTCL. The decision of OPTCL shall be final to the parties hereto.
- 22.2 Any disputes or difference including those considered as such by only one of the parties arising out of or in connection with this contract shall be to the extent possible be settled amicably between the parties. If amicable settlement cannot be reached then all disputed issues shall be settled by Arbitration as provided in this contract.

#### 23. ARBITRATION:

23.1 If at any time any question, dispute or difference whatsoever arises between the OPTCL and the contractor, upon or in relation to or in connection with this contract, either party may forthwith give to the other a notice in writing of the existence of such question, disputes or difference and the same shall be referred to the adjudication of three arbitrators, one to be nominated by OPTCL, the other by the contractor and the third by the President of the Institution of Engineers, India. If either of the parties fail to appoint its arbitrator, within sixty (60) days after receipt of notice for the appointment of its arbitrator then the President of the Institution of Engineers, India shall have the power at the request of either of the parties to appoint an Arbitrator. A certified copy of the "President" making such an appointment shall be furnished to both parties.

- 23.2 The arbitration shall be conducted in accordance with the provisions of Indian Arbitration Act, 1940 or any statutory modification thereof and shall be held at Bhubaneswar in the state of Odisha. The decision of the majority of Arbitrators shall be final and binding upon the parties hereto and the expenses of the arbitration shall be paid as may be determined by the Arbitrators.
- 23.3 Performance under the contract shall if reasonably possible continue during the arbitration proceedings and payments due to the contractor by OPTCL shall not be withheld unless they are the subject matter of the arbitration proceedings.

#### 24 LAWS GOVERNING CONTRACT:

The contract shall be governed according to and subject to the Laws of India and jurisdiction of the Courts of Odisha.

This specification covers the general requirement of OPGW Cable and associated Hardware for stringing of OPGW in Ckt-I of Chandaka – Mancheswar 132KV DC line including installation and commissioning on **live line** (without taking shutdown for the purpose) between EHT Tower Location 14A to 17C as per the enclosed drawing. The existing OPGW between the above two tower locations are to be dismantled initially and then new OPGW is to be provided in the diverted route as per the enclosed drawing.

#### 2.0 APPLICATION:

The purpose of diversion is to facilitate BDA for construction of an ultra modern shopping complex between the EHT Tower location No.14A to17C between Chandaka and Mancheswar 132KV S/S covering distance of 1.8KM. Since the ULDC data from different Sub-LDCs are routed to SLDC through the above OPGW link, immediate restoration of the data link through the diverted route is to be insured within minimum time allowed by the authority.

#### 3.0 TECHNICAL DATA OF OPGW:

DWSM type Optical Fibre Ground wire (8 core) should be used for stringing between the Tower location 14A to 17C. The detailed technical particulars of the

existing OPGW and hardware are enclosed herewith at Annexure-A for due reference. The new OPGW to be supplied by the firm should match to the existing OPGW in the above link so as to avoid excess attenuation of signal. The required OPGW and hardware fittings for the above purpose are as listed below:

**6.0 SAFETY REQUIREMENT:** Dismantling of the existing OPGW cable from tower location No.14A to 17C and further re-stringing in the new diverted link as shown in the

diagram shall be carried out on **live line** i.e. without taking shutdown in the concerned EHT line. However, in case of exigency, the firm may give requisition for necessary shutdown for a minimum period, well in advance.

#### 7.0 SERVICE SUPPORT:

Satisfactory performance of the work along with materials should be guaranteed for a period of 1 year from the date of commissioning. If any fault occurs during the above period, free service support should be extended by the firm to OPTCL for immediate restoration of the link.

#### 8.0 GENERAL CONDITION OF CONTRACT:

- Ø The contractor shall be responsible for the complete engineering, overall coordination, management of the work, transportation of all the materials to the site during dismantling of existing OPGW Cable and stringing of new cable as per Engineer In-charge's advice as and when required.
- Ø The Employer reserves the right to order and delete such works which maybe found necessary within the quantity variation option laid down in the condition of the contract.
- Ø All hardware materials to be supplied under this contract shall comply with this specification(Annexure-A). Any deviation from this specification shall be stated in the relevant Bid proposal schedules and will be considered during Bid evaluation.
- Ø The contractor shall provide at his own cost and expense all labour, material and machineries necessary for the above contract job and shall be entirely responsible for its efficient and correct operation.

- Ø All materials supplied and all work carried out shall comply in every respect with the Regulations and Acts in force as are applicable to the contract works and with any other applicable regulations.
- Ø The contractor shall fully inform himself of the requirement of the local laws, Regulations and rules in force in the state of Orissa especially with respect to licensing requirement, electrical safety rules and regulations and planning procedures.
- Ø The contractor shall provide comprehensive General Liabilities Insurance. The Insurance shall protect the contractor against all claims arising from injuries, disabilities, death of members or public or damage to property of others due to any act or omission on the part of the contractor, its agents, employees, representatives or from riots, strikes etc.
- Ø The contractor shall ensure safety of all the workmen, plant and machineries belonging to him or to others working at the site. The contractor shall also provide all safety measures and safety equipment required by the relevant work as per the contract.

#### **GURANTED TECHNICAL PARTICULARS FOR OPGW**

#### **OPGW**

- 1. OPGW shall be of dual Window Single mode (DW-SM) fiber optic overhead ground wire (OPGW) for Telecommunication department of OPTCL.
  - 1.1 Each Optical fiber shall consist of a core made of fused silica and

cladding surrounding the core shall be also of fused silica.

#### 1.2 Fiber coating


The clad fiber core shall be coated with UV cured urethane acrylate resin.

#### 1.3 Optical fiber unit.

Loose buffer tubes filled with a suitable compound that prevent long term permeation of water, shall be used to protect the optical fiber from the lateral and axial forces. The filling compound shall not drip, flow or leak at 80°C temperature. All loose buffer tubes within a cable shall be stranded around the central strength member. The covering tape shall be a fully dielectric material to form good core configuration and to provide temperature barrier, seamless extruded aluminum tube shall be surrounded over optical fiber unit as heat barrier and for preventing water penetration.

#### 2.4. COMPLETED OPGW

The optical fiber unit shall be surrounded with a number of strands of aluminium clad steel
