#### **COMMERCIAL SPECIFICATION**

#### PART-I SECTION-I INSTRUCTIONS TO TENDERER

#### 1. Submission of Bids:-

Sealed tenders in triplicate in on single part each complete with all respect, in the manner hereinafter specified are to be submitted in the office of GENERAL MANAGER [S&S.]OPTCL, Bhubaneswar on or before the date and time specified against the relevant tender Specification in the notice inviting the tenders. Each copy of the bids (original, duplicate and triplicate) shall be in separate sealed envelopes super scribed on each of the covers the relevant tender Specification number and the due date of opening of the bids on the right hand top side of the envelopes. On the left top sides original/duplicate/triplicate as is relevant, shall be written.

#### 2. Division of Specification:

The Specification is mainly divided into one part viz. Part-I.

#### Part- I Consists of

(i) Section-I : Instructions to Tenderers.

(ii) Section-II : General conditions of supply (commercial)

(iii) Section-III : Schedules and forms etc.
 (iv) Section-IV : Technical Specification.
 (v) Abstract of price components as per Annexure-IV.

(vi) Schedule of prices as per Annexure-V.

#### 3. Tenders shall be in single Parts

The Tenderers are required to submit the tenders in single part in double sealed covers.

#### 4. Opening of Bids.

- (a) The tender shall be opened in the office of the General Manager [S&S.]OPTCL in presence of such of the Tenderers or their authorized representatives (limited to one person only) on the due date of opening of tender and after scrutiny of the technical particulars and other commercial terms, clarifications as may be required, shall be sought for from the bidders. The Tenderers shall be allowed 15 days time for such activity.
- (b) On receipt of technical clarification the bids shall be reviewed/evaluated and those not in conformity with the technical Specification/qualifying experience, shall be rejected. If any of the technical proposals requires modification to make them comparable, discussion will be held with the participating bidders.

All the responsive bidders shall be given opportunity to submit the revised technical and revised price proposals as a follow up to the clarification on the technical proposals. The qualified bidders shall be given opportunity to submit revised price proposals within 15 days from the date of such discussion or within time frame mutually agreed, whichever is earlier.

- (c) The bidders are required to furnish sufficient information to the Purchaser to establish their qualification/capability to manufacture and/or supply the materials/perform the work. Such information shall include details of bidder's experience, its financial, managerial and technical capabilities.
- (d) The bidders are also required to furnish details of availability of appropriate technical staff and capability to perform after sales service where applicable. The above information shall be considered during the first stage of scrutiny and evaluation of bids and any bid which does not satisfactorily meet these requirements, shall not be considered for price bid evaluation.

The price bids of the technically and otherwise acceptable bids, shall only be evaluated as per the norms applicable in terms of this Specification.

#### 5. Purchaser's Right Regarding Alteration of Quantities Tendered.

The Purchaser may alter the quantities of work at the time of placing orders. Initially the Purchaser may place order for lesser quantity with full freedom to place extension orders for further quantity under similar terms and conditions of the original orders. Order may also be split among more than one Tenderer for any particular item if considered necessary in the interest of the Purchaser.

## 6. <u>Procedure & Opening Time of Tenders:</u>

Tenders will be opened in the office of the General Manager (S&S) on the specified date and time in present of such of the Tenderers or their authorized representatives (limited to one person only) in case of each bidders who may desire to be present, at the time of opening the bids. The General Manager (S&S) or his authorized representatives will, on opening each bid, read aloud the name of the bidder. He shall also read aloud the attested and un-attested corrections and shall record the number of such corrections on each page of the technical bid over his dated initials and also initial all such corrections.

#### 7. <u>Bidder's Liberty to Deviate from Specification</u>:

The Tenderer may deviate from the Specification while quoting if in his opinion such deviation is in the line with the manufacturer's standard practice and conducive to a better and more economical offer. All such deviations should however be clearly indicated giving full justifications for such deviation. (Read with Clause-9, Section-II of the Specification).

#### 8. Eligibility for Submission of Bids.

Tenderers who have purchased the Specification from the office or downloaded from the official website of OPTCL & deposited the tender cost while submitting the tender will only be considered.

#### 9. Purchaser's Right to Accept/Reject Bids.

The purchaser reserves the right to reject any or all the tenders without assigning any reasons what so ever if it is in the interest of OPTCL under the existing circumstances. (Read with Clause-10, Section-II of the Specification).

#### 10. Mode of Submission of Bids.

- (A) Bids, complete in all respect shall be submitted in person or by registered Post with A.D. Any other mode shall not be accepted. When delivered in person, the tenders shall be received by a responsible officer of the office of the General Manager (S&S), OPTCL who shall officially acknowledge the receipt of the same. Tenders received after due date and time shall be returned un-opened.
- (B) <u>Telegraphic</u>, <u>Telephonic</u> or <u>FAX Tenders</u> shall not be accepted under any circumstances.

#### (i) <u>Earnest Money Deposit</u>.

The tender shall be accompanied by Earnest Money Deposit of value specified in the notice inviting tenders against each lot/bid. Tenders without the required E.M.D. will be rejected outright. The earnest money deposit shall be furnished in one of the following forms subject to the conditions mentioned below:

- (a) Cash: Payable to General Manager, Stores Circle, OPTCL, Bhubaneswar
- **(b) Bank Draft**: To be drawn in favour of the General Manager, Stores Circle OPTCL, Bhubaneswar -751022.
- (c) Bank Guarantee from any nationalized/scheduled Bank strictly as per enclosed proforma vide Annexure-VI to be executed on non-judicial stamp paper of appropriate value worth Rs.29/- to be accompanied by the confirmation letter of the issuing Bank. The validity of the E.M.D. Bank Guarantee shall be 240 days from the date of opening of tender, failing which the tender will be liable for rejection.

No interest shall be paid on the Earnest Money Deposit. Up to Rs.25,000/- (Rupees twenty-five thousand only) the Earnest Money Deposit may be furnished either in shape of cash or Bank Draft. Above Rs.25,000/- (Rupees Twenty Five Thousand only) the Earnest Money Deposit shall be furnished in shape of NSCs or EMD Bank Guarantee, as per proforma attached.

- (i) No adjustment towards Earnest Money Deposit shall be permitted against any outstanding amount with the Odisha Power Transmission Corporation Limited
- (ii) In the case of un-successful Tenderer the Earnest Money will be refunded Immediately after the tender is decided. In the case of successful tenderer, EMD will be refunded only after furnishing of security money referred to at Clause-19 of section –II. Suits if any, arising out of this Clause shall be filed in a Court of law to which the jurisdiction of high court of Odisha extends.
- (iii) Earnest Money will be forfeited if the Tenderer fails to accept the letter of intent and /or purchase orders issued in his favour.
- (iv) Tenders not accompanied by Earnest Money/documentary proof of Exemption of E.M.D. shall be summarily rejected.

#### 12. **Validity of the Bids**

The tenders should be kept valid for a period of 180 days from the date of opening of the tender as notified in the tender notice failing which the tenders will be rejected.

PRICE Tenderers are requested to quote FIRM price only.

#### 14. Revision of Tender Price By Bidders

- (a) After opening of tenders and within the validity period, no reduction or Enhancement in price will be entertained. If there is any change in price, the tender shall stand rejected and E.M.D. deposited shall be forfeited. In case of bidders who are exempted from depositing E.M.D. and who revise their price within the validity period, the bids for similar items against subsequent tender call notice of OPTCL, may not be considered.
- (b) If required, the Tenderers may be asked to extend the validity period of bids under the same terms and conditions as per the original tender except for the change in delivery period, In such an event the Tenderers are free to change any or all conditions of their bids including price at their own risk.

#### 15. Tenderers to be fully Conversant with the Clauses of the Specification.

Tenderers are expected to be fully conversant with the meaning of all the Clauses of the Specification before submitting their tenders. In case of doubt regarding the meaning of any Clause the Tenderer may seek clarification in writing from the General Manager, Stores Circle OPTCL. This however, does not entitle the Tenderer to ask for time beyond due date fixed for receipt of tender.

#### PART - I SECTION - II GENERAL TERMS & CONDITIONS OF CONTRACT (G.T.C.C)

#### 1. Scope of the Contract

To undertake the electrical maintenance work of the following types of at various offices of OPTCL as follows:

- a) Maintenance and operation of electrical installations of OPTCL's office buildings at Multistoreyed Building, Administrative Wing, Finance wing, Technical building, Power Club, Hospital, Transit House, UGME school, Management Training Center at Kalyani Complex Unit 8, Bhubaneswar and core skills training center and power Training Center at Chandaka under OPTCL.
- b) Operation of 2 Nos. of lifts at Multistoreyed Building, OPTCL, Bhubaneswar.
- c) Operation of 2 Nos. of 75Ton Central A.C. Plant at Multistoreyed Building, OPTCL, Bhubaneswar.
- d) Operation of Fire Hydrant System at Multistoreyed Building, OPTCL, Bhubaneswar.
- e) Operation of 2Nos. of 320KVA DG Set at Multistoreyed Building, OPTCL, Bhubaneswar.
- f) Operation of 1Nos. of 100KVA DG Set at AW Building, OPTCL, Bhubaneswar (Future Assignment).
- g) Maintenance of Electrical Installations of occupants of various types of quarters of OPTCL Colonies situated at Bhoinagar, Chandrasekharpur & SLDC, Mancheswar, BBSR.
- h) Any other place not mentioned above but required to maintain as per the instruction of SDO (Elect.), EM Cell, OPTCL, Bhubaneswar.

#### 2. Deployment of Personnel's:

A team of authorized workmen with ID cards having valid electrical workman's permit issued by ELBO, Bhubaneswar/ ITI Certificate holder shall be deployed at specified placed stated above. A qualified supervisor should also be available during office hours to supervise the work. Adequate and proper personnel as required should be arranged during any emergency apart from the regular personnel's available at specified sites. In case the workmanship of any deployed personnel is found unsatisfactory and reported, the person will be replaced within one month.

It is the responsibility of the contractor to depute substitute staff for the earmarked staff if found remaining absent from the duty.

Separate complaint registers are to be maintained for office, colonies at Bhoi nagar, SLDC, Mancheswar and Chandrasekharpur to attend complaints for immediate rectification. The attendance registers shall be maintained by you for the staff deployed which will be periodically checked by the SDO (Elect.), EM Cell, OPTCL, Bhubaneswar.

The working hours of different places for deployment of workmen is mentioned below.

#### A. For Office Buildings:

- I) From 9.00 AM to 9.00 PM on all working days.
- II) From 9.00 AM to 6.00 PM on holidays.
- III) From 9.00 AM to 9.00 PM for lift operation on all working days.
- IV) AW Building: Round the clock. (Three Shifts)
- V) Multistoreyed Building: Round the clock. (Three Shifts)

#### B. For each Colonies:

All week days – Round the clock. (Three Shifts)

Deployment of personals also be so arranged, that in no case any complaint shall remain unattended from the preceding day as far as practicable. A deployment chart for each month is to be furnished by you. In case the performance is found unsatisfactory, the contract will be terminated on serving one month's notice from OPTCL side.

3. Description of work: All types of repairing or replacement of electrical installations including wiring for fan, fitting and other electrical appliances etc. are within the scope of work. The consumables like PVC insulating tapes/ Black tapes / ampere tapes, fuse wires, Lubricant oil, markin cloths, cotton waste etc. will be provided by the you as and when required during maintenance. All types of tools

and tackles, testing and measuring instruments required for the work shall be provided by you. The materials such as tube light, bulb, holder, switch, sockets & other wiring materials will be supplied by OPTCL.

- 4. Supply of Materials: The supply of materials required for day to day maintenance and operation of electrical installations will be supplied by you as per proper requisition received from SDO, EM Cell, OPTCL, Bhubaneswar. No extra amount will be paid towards transportation, handling, storage and overhead expenses
- 5. (a) EPF & ESI: It is your responsibility to deposit EPF and ESI of personnel engaged for the work by you. The Xerox copy of proof of deposit of EPF & ESI in each employee of the previous month must be submitted along with the bills for verification & record. The health card from ESI must be issued to all employee within three months of issues of this work order.

Liability for Workman's compensation if any: This shall be borne by you and OPTCL shall not have any liability what-so-ever in this regard.

- 6. Wages & Bonus: All the employee engaged in this office should get wages as per minimum wages rules of Govt. of Odisha. Any enhance in the wages by Govt. of Odisha, will be bear by the organization. The minimum bonus should be paid to all employees once in a year.
- 7. Uniform: A good looking uniform, boot, helmet & tool bag with Identity card should provided to all employees for easy identification.

#### 8.0 **Definition of Terms**

For the purpose of this Specification and General Terms & Conditions of Contract (G.T.C.C.) the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 8.1 "The Purchaser" shall mean the General Manager (S&S) for & on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD., Bhubaneswar.
- 8.2 "The Engineer" shall mean the engineer appointed by the Purchaser for the purpose of this contract.
- 8.3.1 "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- 8.4 "The Contractor" shall mean the Bidder whose bid has been accepted by the Purchaser and shall include the Bidders' executives, Administrators, Successors and permitted assignees.
- 8.5 "Equipment" shall mean and include all machinery, apparatus, Materials, articles to be provided under the contract by the Contractor.
- 8.6 "Contract Price" shall mean the sum named in or calculated in accordance with the provisions of the contract as the "Contract Price" which shall include packing, forwarding, freight, insurance excise duty, sales tax, Octroi and other taxes and duties as applicable at the time of opening of bids.
- 8.7 "General Conditions" shall mean these General Terms and Conditions of Contract.
- 8.8 "The Specification" shall mean the Specification annexed to or issued with G.T.C.C. and shall include the schedules & drawings attached thereto as well as all samples and pattern, if any.
- 8.9 "Month" shall mean "Calendar month".
- 8.10 "Writing" shall include any manuscript, type written, printed or other statement re-production in any visible form and whether under seal or under hand.
- 8.11 "F.O.R. Destination Costs" shall mean the cost of equipment and material at the consignee's stores. The cost is exclusive of Excise duty, Sales Tax and other Local Taxes, but is inclusive of packing, forwarding and insurance and freight charges.
- 8.12 The term "Contract documents" shall mean and include G.T.C.C., Specifications, Schedules, Drawings, Form of Tender, Covering Letter, Schedule of Price of the final successful bidder any special conditions applicable to the particular contract, Specifications and drawings and the purchase order & the agreement to be entered into.
- 8.13 Terms and Conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that, in the Odisha General Clauses Act.

#### 9. Manner of Execution

All equipments supplied under the contract shall be manufactured in the manner set out in the Specification or where not set out, to the reasonable satisfaction of the Purchaser's representative.

#### 10. Rejection of Materials

In the event any of the materials/equipment supplied by the Contractor is found defective due to faulty design, bad workmanship, bad materials used or otherwise not in conformity with the requirements of the Specification, the Purchaser shall either reject the materials/equipment or ask the

Contractor in writing to rectify the same. The Contractor on receipt of such notification shall either rectify or replace the defective equipment free of cost of the Purchaser. If the Contractor fails to do so, the Purchaser may:-

- (a) As its option, replace or rectify such defective equipment and recover the extra costs so involved from the Contractor plus fifteen percent and /or.
- (b) Terminate the contract for balance work/supplies, with enforcement of penalty Clause as per contract for the un-delivered goods and with forfeiture of performance Guarantee/Composite Bank Guarantee.
- (c) Acquire the defective equipment/materials at reduced price, considered equitable under the circumstances.

#### 11. Experience of Bidders:

The bidders should furnish information regarding experience particularly on the following points:-

- i) Name of the work.
- ii) Standing of the firm and equipment.
- iii) Description of equipment similar to the quoted, supplied and installed during the last four years with the name(s) of the party(s) to whom supplies were made:

#### 12. Language and Measures

All documents pertaining to the contract including Specifications, Schedule, Notices, Correspondence, Operating & Maintenance instructions, Drawings or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

#### 13. <u>Deviation from Specification</u>

It is in the interest of the Tenderers to study the Specification, drawing etc. specified in the tender schedule thoroughly before tendering so that, if any deviations are made by the Tenderers the same are prominently brought out on a separate sheet under heading "Deviations".

A list of deviation shall be enclosed with the Tender. Unless deviation in scope, technical and commercial stipulations are specifically mentioned in the list of deviations, it shall be presumed that the Tenderer has accepted all the conditions stipulated in the tender Specification, not withstanding any exemptions mentioned therein.

#### 14. Right to Reject/Accept Any Tender

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the Purchaser. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of materials at the time of placing final Purchase order. After placing of the order, the Purchaser may defer the delivery of the materials. It may be clearly understood by the Tenderer that the Purchaser need not, assign any reason for the above action(s).

#### 11. Contractor to inform himself fully

The Contractor shall examine the instructions to Tenderers, General Conditions of contract, Specification and the Schedules of Quantity and delivery to satisfy himself as to all terms and conditions and circumstances affecting the contract price. He shall quote price(s) according to his own views on these matters and understand that additional allowances except as otherwise provided therein will be levied. The Purchaser shall not be responsible for any misunderstanding or incorrect information obtaining by the Contractor other than the information given to the Contractor in writing by the Purchaser.

#### 12. Patent Rights Etc.

The Contractor shall indemnify the Purchaser against all claims, actions, suits and proceedings for the infringement or alleged infringement of any patent design or copy right protected either in the country of origin or in India by the use of any equipment/ materials supplied by the Contractor. But such indemnity shall not cover any use of the equipment, other than for the purpose indicated by or reasonably to be inferred from the Specification.

#### 13. **Delivery**

- (a) Time being essence of the contract, the equipments/ Repair shall be completed within the completion date specified in the contract.
- (b) The desired completion period shall not ordinarily exceed more than 2 days.

#### 14. <u>Contractor's Default Liability</u>.

- The Purchaser may, upon written notice of default to the Contractor, terminate the contract in circumstanced detailed hereunder.
- (a) If in the judgment of the Purchaser, the Contractor fails to make delivery of equipment/completion of repair within the time specified in the contract or within the period for which

extension has been granted by the Purchaser in writing in response to written request of the Contractor, &/ or,

(b) If in the judgment of the Purchaser, the Contractor fails to comply with any of the provisions of this contract.

#### 15. Force Majeure:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force Majeure such as acts of God, acts of the public enemy, acts of Govt., Fires, Floods, Epidemics, Quarantine restrictions, strikes, Freight Embargo, provided that the Contractor shall within ten (10) days from the beginning of such delay notify the Purchaser in writing of the cause of delay, upon which, the Purchaser shall verify the facts and grant such extension as facts justify.

#### 16. Guarantee Period.

The materials supplied by you covered under the contract should be guaranteed for satisfactory operation, against bad design, materials and workmanship for the period of Annual Maintenance Contract. Any defect if noticed during this period shall be rectified / replaced by you free of cost provided such defects are due to bad design, manufacturing practice, workmanship or materials used, upon written notice from the purchaser.

#### 17. Bank Guarantee towards Security Deposit, 100% Payment and performance Guarantee.

- i) The successful bidder has to submit a composite Bank Guarantee for `1.0Lakh (Rupees one lakh only) in favour of Chairman cum Managing Director, OPTCL, Bhubaneswar & valid for a period of 38 months from the date of award of workorder.
