**CORRIGENDUM NO.3 TO TENDER NOTICE NO.21/2007-08.**

Some Clauses and Annexures of the Tender Specification No.Sr. GM-CPC-AUTOTRANS-37/07-08 and No.SR.GM-CPC-POWERTRANS-38/07-08 have been amended. Interested Manufacturers may visit OPTCL's Official Website <http://www.OPTCL.Co> in for detail amendments.

**Followings are amendments to some Clauses & Annexures of Tender Specifications No. Sr.G.M.-CPC-POWERTRANS-38/07-08 for 40 MVA, 20 MVA, 132/33 KV Power Transformers and No. Sr.GM-CPC-Autotrans-37/07-08 for 160 MVA, 100 MVA, 220/132/33 KV Autotransformers:-**

1. The clause No.30 and clause No.34 of Part-I, Section-II of the above Tender Specifications are hereby substituted by the followings:

**Clause No. 30:- Qualifying Requirement of Bidder (QR):-**

- a)** The bidder should have manufacture and supply experience of the rating as tendered or higher capacity Transformers (both MVA & Voltage rating) for a minimum period of 5 (five) years as on the date of opening of the Techno-Commercial bid.
- b)** At least 5 (five) Nos. Transformers of rating, as tendered or higher capacity (both MVA and Voltage rating) should have been supplied successfully.
- c)** The rating, as tendered or higher capacity (both MVA and Voltage rating) transformer(s) should have at least 3 (three) years successful performance from the date of commissioning.

- d) The tenderer who have manufacturing unit in India and is a part of parent company, located elsewhere, and is meeting above qualifying criteria by the parent company, can also participate, provided the Indian unit has minimum 2 (two) years manufacturing and supply experience of the same rating, as tendered or higher capacity ( both MVA and voltage rating) and performance certificate of satisfactory operation from the user for a minimum period of 1 (one) year from the date of commissioning of the transformer is submitted. The tenderer in such case shall also furnish a legally enforceable Undertaking jointly with the parent Company to guarantee quality, timely supply, performance and guarantee obligations as per Annexure-XVI on award of contract and a confirmation letter from parent Company (Principals) as per Annexure-XV, enclosed shall be submitted alongwith the Bid.
- e) The Indian bidder(s) who do not meet the above qualifying criteria [Sl.(a) to (d)], but have valid collaboration with other transformer manufacturer or is a part of parent company shall meet the following stipulations:-
- i) The collaborator or parent company should have at least 10 (ten) years experience in the design, manufacture, testing and supply of the rating, as tendered or for higher capacity (both MVA and Voltage rating), which have been in satisfactory operation for at least 7 (seven) years. In such an event, the bidder who has valid collaboration shall furnish alongwith his bid, documentary evidence in support of experience and satisfactory operation as mentioned above including a copy of the notorised collaboration agreement/ licensing agreement. In case of the bidder, being part of parent company, they have to furnish a legally enforceable undertaking jointly with the parent company to guarantee quality, timely supply, performance and guarantee obligations as per Annexure-XVI on award of contract and a confirmation letter from a parent company (principals) as per Annexure-XV, enclosed shall be submitted alongwith the Bid.
- ii) Purchase Order(s) from Govt. of India/ State Governments or other undertakings for rating, as tendered or higher capacity (both MVA and Voltage rating) should have been placed with the Indian Bidder(s). The Bidder(s) should furnish the copies of such Purchase Order(s) alongwith their offer, supported with documents as regard to proven capability, as mentioned in Clause-iii, herein below.
- iii) The Indian Bidder should have adequate manufacturing facility, testing facility (for all tests as per Specification), experienced engineers and working personnel, R&D facility, financial capability, the collaborator's/ parent Company's participation in regard to design, manufacturing, testing and R&D etc., which will be determined before award of contract. Not withstanding anything, stated above, the purchaser reserves the right to assess the bidder's

capability and capacity to perform the contract, should circumstances warrant such an assessment in the overall interest of the purchaser.

- iv) The tenderer should have a minimum turn-over of 15 crores in any one financial year during the previous three years.
- v) In the event of order, the firm have to furnish guarantee for the transformer for a minimum period of 48 (Forty eight) months from the date of commissioning or 54 (fifty four) months from the date of supply, whichever is earlier. The firm have to furnish composite B.G. of 20% of the contract value which should be valid for 56 (fifty six) months from the date of supply.
- vi) The tenderer should have adequate infrastructural facility for "after sales service".
- f) The bidder shall furnish type test reports with his bid. All type tests conducted on the rating (both MVA and voltage class) or higher capacity (both MVA & voltage rating) shall be as per relevant IS/IEC in recognized laboratory. The date of type test shall not be earlier than five years as on the date of bid opening. The bids, received without type test reports may be treated as non-responsive. In case of category (d) and (e) above, the type test reports of collaborator/ parent company are also applicable.
- g) Copies of documents, defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership or collaborator or parent Company etc. shall be furnished alongwith the bid.
- h) Even though the bidder meets the above qualifying criteria, they are subject to be disqualified if they have
  - i) made misleading or false representations in the forms, statements and attachments, submitted in proof of qualification requirements and/ or
  - ii) record of poor performance such as not properly completing the contract, inordinate delays in completion of supply, litigation history or financial failure etc.
- i) Notwithstanding anything stated above, the purchaser reserves the right to assess the Bidder's capability and capacity to perform the contract within the scheduled time, should circumstances warrant such assessment in the overall interest of the Purchaser.

**N.B:-** In absence of valid collaboration agreement as at Clause-30 (e) (i)

above, the proforma as per Annexure-XIV of Section-III of the above Specifications may please be used for submission along with Tender papers.

**Clause No. 34 – Outright Rejection of Tenders :-**

Tenders shall be outrightly rejected if the followings are not complied with –

- i) The Tenderer should have purchased/ obtained the Bid Specification document from the office of the Purchaser or downloaded the same from website of OPTCL, but shall deposit the tender cost, while submitting the tender.
- ii) The tender shall be submitted in person or by Registered Post with A.D.
- iii) The Tender shall not be submitted telegraphically or by Fax.
- iv) The Tender shall be accompanied by the prescribed Earnest Money deposit unless otherwise qualified from exemption from furnishing of E.M.D.
- v) The tender shall be kept valid for a minimum period of 120 days from the date of opening of tender.
- vi) The Tender shall be submitted in two parts, as specified.
- vii) The schedule of price should be filled up fully to indicate the break-up of the prices including taxes and duties. Incomplete submission of this schedule will make the tender liable for rejection, vide Clause No. 4 (ii) of Part-II.
- viii) The Tenderer should quote "VARIABLE PRICE" as per IEEMA PVC and the price should be kept valid for a minimum period of 120 days from the date of opening of the Tender.
- ix) Guaranteed Technical Particulars and abstract of terms and conditions should be filled in properly.
- x) Bids, offering completion of delivery, longer than 14 weeks after the delivery period, specified in this Specification, will be rejected.
- xi) The Tenderer should fulfill the "Qualifying Requirement" as per Clause No. 30 of Part-I, Section-II of this Specification, as amended above.

2. **Clause No. 1 of Part-I, Section-I of the Specification:-**

The said clause stipulating "The participants to the tender should be registered under Orissa Sales Tax Act, 1947" is hereby amended as "The participants to the tender should be registered under "Central Sales Tax Act"/ "Orissa Sales Tax Act".

3. **ANNEXURE-I (DECLARATION FORM):-** SL.5 is substituted by the following:- " In the event of tender, being decided in \*my/our favour, \*I/We are to furnish the Composite B.G in the manner, acceptable to ORISSA POWER TRANSMISSION CORPORATION LIMITED, and for the sum as applicable to \*me/us as per \*clause-19 of section-II/ \*Clause-30 (e) (v) of section-II of this specification within 15 days of issue of letter of intent/purchase order failing which, \*I/We clearly understand that the said letter of Intent/Purchase order will be liable to be withdrawn by the purchaser and the EMD, deposited by us shall be forfeited by OPTCL"
