## <u>Amendments to Tender Specification No.Sr.GM-CPC-Telecom-OPGW</u> <u>Stringing-48/2011</u>.

The following terms are amended in the Tender Specification No. Sr.GM-CPC-Telecom-OPGW Stringing-48/2011 following the 1st Corrigendum to **Tender Notice No.39/2011**.

1. General:

2. Section-I of Pat-I- Instruction to tenders:

(a) Clause-13: Adequate Experience in supply of OPGW is exempted.

3. Section-II of Part-I, General Conditions of contract:

- (a) Clause-3: Manner of Execution Supply of OPGW by the bidder is optional. They are required to supply necessary hard wares & fittings for a line length of 1.8 Km
- (b) Test certificates: Furnishing of type test & Routine test certificate for OPGW is not required.
- 4. Section-III of Part-I Schedules and Annexures:

The term for supply of OPGW mentioned in Annexure-IV (Personnel capabilities) & Annexure-IV (Equipment capabilities) are not to be considered.

- 5. Section-IV: **Technical Specification**:
  - (i) Execution of the work:-
