We would like to know whether we will do all the required activities for all the 3 websites.	Yes, you have to do all the required activities for all the 3 websites.
2		Search Engine Optimization is a continuous process to obtain top position in the popular search engines. So do you want a comprehensive quote for it or a monthly quote?	We want a comprehensive quote.
3		It is mentioned in the scope of the work that we need to extract email ids from the websites and build an email database and bulk mails to them. We need clarity on: a. We will extract email ids from which sites? b. What will be the format of bulk emails? For ex- HTML, RTF, Normal mails or all.	E-mail ids of all the Employees will be there in our website and those are to be dumped into an e-mail database. The format of bulk e-mails should be in HTML format.
4		Do you want a content Management System (CMS) for all the links of the website or for some specific ones?	We want CMS for some specific links.
5		Do you want a flash website or a website having some flash elements in it?	The website should have some flash elements in it.
6		You want a bilingual website in Oriya and English. Please confirm.	Yes, we need our websites to be bilingual(i.e. in English and Oriya).
7		You have mentioned about role based access. We assume it is for the CMS part. Please clarify.	Role-based access control (RBAC) Should enable Mail administrator to delegate permissions to responsible users based on job function without giving them access to the entire Mail management interface.
